How do distributors place orders in India?

- 1 Distributors can place orders by walk-in, phone, fax, and internet.
- 2 Accepted methods of payment include, cash, demand drafts credit card (AMEX, Visa, and MasterCard), or bank wire. Wires need to have the ID number and Order number included in the details.

How are commissions paid to India distributors?

In order to receive a commission, a distributor must submit a copy of the PAN card to the 4Life India office. TDS will be deducted from the commission. Bonus cheques or wires are sent for commissions of at least Rs.400. Commissions under Rs. 400 will be credited to the distributor's account and paid out once Rs. 400 is reached.

In order to receive a bank wire, 4Life must receive a voided personal cheque. If a voided personal cheque is not received the commission will be paid by Cheque

Cheques or wires will be sent out on the 21st of every month.

Are there any unique differences with 4Life India that I need to be aware of?

4Life India is not allowed to sell products or take payment from foreign distributors. It also does not have a Preferred Customer program due to Indian Law.

Are there any differences in the compensation plan?

New enrolling distributors can qualify to be paid as a Leader by purchasing 50 LP every month for the first three months.

International Diamonds and Presidential Diamonds are also given an additional way to qualify. International Diamonds can qualify by have 10,000 3-Level Volume and 50,000 GLP or with the standard 3-Level and group volume. Also Presidential Diamonds can qualify with 5000 3-Level Volume and 25,000 GLP or with the standard 3-Level and group volume.
